

# RESPECTIVE FUNCTIONS OF THE BOARD OF GOVERNORS AND PRINCIPAL IN RELATION TO ADMISSIONS

The Board of Governors draw up and apply the criteria for admissions.

#### ADMISSIONS CRITERIA

During the admissions procedure when applying the criteria <u>punctual applications</u> will be considered before <u>late applications</u> are considered. The application procedure opens on 7 January 2021 at 12 noon (GMT) and an application submitted by the closing date of 29 January 2021 at 12 noon (GMT) will be treated as a <u>punctual application</u>. An application received after 12 noon (GMT) on 29 January 2021 will be treated as a <u>late application</u>.

The Board of Governors will apply the following criteria in the order indicated to identify which children should be admitted either at initial admission to education or on transfer from another school.

- 1. Children of compulsory school age who have brothers/sisters (half-brothers/sisters) currently enrolled in the school. (This is to ensure that siblings can be educated together).
- 2. Children of compulsory school age who normally reside in the Parish of Aghaderg.
- 3. Children of compulsory school age who reside in other areas.

In the event of over-subscription in any one of the criteria, taken in order, the following sub-criteria will be applied in the order set down:

- i. Children of compulsory school age who have listed St Francis' Primary School Aghaderg as their first preference.
- ii. Children of compulsory school age whose parent/guardian is a prior pupil of the school, or former parish schools.
- iii. In the event of over-subscription in any criterion, selection for all places remaining in this category will be on the basis of initial letter of the surname, in the order set out below.

#### NTUZLWXDGHQYJEFCRBSPVAOKMI

The above was determined by a randomised selection of letters of the alphabet carried out by the Board of Governors on 24<sup>th</sup> November 2020. Where surnames begin with the same initial letter, the subsequent letters of the surnames will be used in alphabetical order. In the event of two identical surnames the alphabetical order of the initials of the forenames will be used.

#### **DUTY TO VERIFY**

The Board of Governors reserves the right to require such supplementary evidence as it may determine to support or verify information on any application. Documentation submitted in support of your application should be provided directly to the school of first preference. If the requested evidence is not provided to the Board of Governors by the deadline given, this will result in the withdrawal of an offer of a place. Similarly, if information is supplied which appears to be false or misleading in any material way, the offer of a place will be withdrawn. Birth Certificates must be supplied to the school by 5<sup>th</sup> February 2021.

#### WAITING LIST POLICY

Should a vacancy arise after 28<sup>th</sup> April 2021, all applications for admission to Primary 1 that were initially refused, new applications, late applications and applications where new information has been provided, will be treated equally and the published criteria applied. This waiting list will be in place until 30<sup>th</sup> June 2022. The school will contact you in writing if a child gains a place in the school by this method.

Your child's name will not be automatically added to the list. Please inform the school in writing if you want your child's name added to the list.

#### ADMISSION TO P2-P7

Admission to Primary 2 to Primary 7 and admission to Primary 1 later in the school year are subject to the enrolment number not being exceeded and to any admission not being prejudicial to the efficient use of resources.

#### **SCHOOL HOURS**

During the 2020/21 year, the school day has been impacted by Covid-19. In the event that the restrictions are relaxed, the draft school hours are as follows:

The school opens at 8:00am for children attending our Morning Club. For children **not** attending the Morning Club the school will open at 8.45am; all children should be in the school for roll call at 9.00am. Lunch is from 12.15pm - 1.00pm. A 'Bus Club' operates from 2.00 until 3.00pm for children who travel to or from school by bus. A range of after-school activities operate from 2:00pm until 3:00pm for Primary 1 - 3 pupils and from 3:00pm until 4:00pm for Primary 4 - 7 pupils. Please contact the school for further details on the Morning Club or after school activities. Parents are asked to arrange to have their children collected by 3.10 pm as on occasions the staff have to attend In-Service Training Courses after school.

The school utilises a school app to inform parents; the success of these systems depends on parents providing us with up to date contact details or downloading the school app (www.edtap.com). In the event of an emergency closure every attempt will be made to notify parents to enable them to make alternative arrangements. Please check that we have your full address and at least one up to date phone contact number.

#### **PASTORAL CARE ARRANGEMENTS**

We will endeavour to provide a comfortable and safe environment for learning. Each class teacher has the responsibility to look after the pastoral needs of the children in his/her class. Parents are asked to inform the teachers of any medical problems their child may suffer, any medication their child is receiving and an up to date address or phone number at which they (or the child minder) may be contacted. In the event of an emergency, arrangements will be made to have the child taken to hospital. In all cases it will be the school policy to act in the best interest of the child. In the event of a parent having concerns about a Pastoral Care or Child Protection issue the following teachers should be contacted:

Mr E O'Malley (Designated Teacher for Child Protection) or Mrs K Trainor (Deputy Designated Teacher for Child Protection).

#### **SCHOOL DISCIPLINE**

In St. Francis' Primary School, we believe that without discipline there is no learning. A positive approach is used. Children will be encouraged to be polite and good mannered to teachers, other members of staff, visitors and to each other. In the interest of safety, children will be encouraged to walk at all times within the school and show caution in the school grounds. Good behaviour will be expected from all pupils within the school grounds and at all times when pupils from St. Francis' leave the school during school hours for school trips, sporting activities or religious ceremonies. Merit and reward systems operate at class level to encourage positive behaviour. Unacceptable conduct such as, disruptive behaviour within the classroom, bad manners, insolence, disobedience, foul language, physical attack, unsporting behaviour and rough play will not be tolerated. When unacceptable behaviour occurs, the necessary sanctions will be employed as detailed in the School's Discipline Policy.

Copies of the School's Child Protection, Behaviour Management and Discipline Policies are

available in the school.

#### **SCHOOL CURRICULUM POLICY**

#### **Curriculum Policy Statements**

It is the policy of the Board of governors of St Francis' Primary School that each child will receive, at a minimum their full entitlement under the Northern Ireland Curriculum.

"The Northern Ireland Curriculum aims to empower young people to achieve their potential and to make informed and responsible decisions throughout their lives"

It comprises seven general learning areas: Language and Literacy; Mathematics and Numeracy; the World Around Us; the Arts; Personal Development; Physical Education and Religious Education. At the heart of the curriculum lies an emphasis on the development of skills: (a) Thinking Skills and Personal Capabilities and (b) formally assessed cross curricular skills: using Mathematics, Communications and ICT. The Northern Ireland Curriculum embraces the principles of Assessment for Learning with an emphasis on improvement, raising achievement and celebrating success.



to promote a spirit of tolerance towards others.

St Francis' Primary School offers a balanced and broadly based curriculum which promotes the intellectual, spiritual, moral, cultural, emotional and physical development of pupils. The curriculum is designed to encourage the desire to learn and to stimulate thinking and reasoning.

It is important that children learn to apply themselves to their school work. The acquisition of knowledge and skills is important; however, this must be placed in the context of the development of sound moral values based on Catholic Faith. The school will promote the principles of Catholic Education by giving everyone the opportunity to make themselves educated Christian persons. Staff will be available to attend to children's needs, these problems and confidences will be taken seriously so that they gain in self-confidence and are certain of the teacher's love and friendship.





Learning will be a source of pleasure; this can be achieved through work of a practical nature. Practical work includes Drama in Literacy, RE and History; practical work and experiments in Numeracy, Science and Geography and field studies in the World Around Us. Pupils are offered a range of extra-curricular activities, either within the school day or after school. Participation in these activities is voluntary, though places may be limited. Activities include; Gaelic football, camogie/hurling, tin whistle, fiddle, choir, Irish dancing, Spanish, art and cycling proficiency. Music tuition is also offered by the EANI Music Service. After school activities on offer in previous years include: drama, soccer, Gaelic football, ukulele and yoga. It is hoped to reintroduce these activities when it is safe to do so.





#### **RELIGIOUS EDUCATION**

St Francis' is a Catholic school conducted in accordance with the rites, practices and observance of the Catholic faith. It is expected that children admitted to the school will take a full and active part in the religious life of the community. The school will promote the principles of Catholic education by giving all the opportunity to make themselves educated Christian persons. Christian belief and attitudes will pervade all teaching. Christian values and beliefs are not just confined to the Religion class but are part of the whole school curriculum. Formal religious education takes up at least 10% of teaching time and is based principally upon the Grow In Love religious scheme. Prayer is part of the daily school life and school masses, confessions and other religious services are part of the yearly programme. We acknowledge the role of parents in the children's religious education; the school builds on the foundation they have laid. Parents are also involved in the preparation of their children for the Sacraments of Reconciliation, Communion and Confirmation. Fr Corr and parish representatives also assist the children and their parents in the preparation for these sacraments.

Parents of children from a non-Catholic background can contact the school regarding arrangements for religious instruction.



#### **DRUGS EDUCATION**

St Francis' Primary School, Aghaderg is a caring, responsible school with the children at the core of our activities. We strive to respond to the personal, emotional, social and educational needs of our pupils through our interaction with them in the classroom and beyond.

Each primary school is obliged to refer to its drugs education policy within its prospectus. The emphasis of our drugs education programme is on the dangers involved in the misuse of tobacco, alcohol and medicine. The school avails of the Education Authority's Pastoral Care and Personal Development team for the delivery of the RSE programme. As our programme responds to need, we will include other substances when appropriate. This programme is delivered mainly through religious education, PDMU and the World Around Us curriculum. All other subjects contribute to this, where and when appropriate.

We do not condone the misuse of drugs nor do we wish to sensationalise or dramatise the drugs situation. We believe in providing a drugs education programme, which is appropriate to the experience of children in our school. The programme we provide helps to equip our pupils with the skills to respond and react appropriately to situations, which are hazardous to their health. Underpinning our teaching is the belief in building the children's self-esteem; in helping them value themselves and others; in giving them a sense of their responsibility to themselves and others. We recognise this as a partnership between the school and the parents, where we work together towards educating and preparing our children for each stage of their lives.



#### **CHILDREN WITH SPECIAL EDUCATIONAL NEEDS**

Some of the children attending the school will have special educational needs. These may arise from the child's physical incapacities or learning difficulties. As it is the policy of the school to maximise the potential of each pupil – the school will endeavour, within its resources, to meet these needs. Having been informed of, or having identified, an educational need the school will follow the requirements of the Code of Practice in regard to parental involvement, school based help and the involvement of other agencies (e.g. Educational Psychologists).

A Register of pupils with Special Educational Needs is maintained by the SENCO. To supplement differentiation within the classroom, children experiencing difficulties may receive additional assistance.

#### **HOMEWORK**

Homework is an important part of the learning process. It is a means of revising work done in class, extending work done in school and using information, which is not available in the school. Homework may be done in booklets or online through the **Seesaw app**; this involves the parents in the learning process and is a means of keeping parents abreast of the curriculum that is being taught. Homework will be based on one or more of the following: Reading, Spellings, Literacy, Numeracy, other curricular areas or personal research. The amount of homework should generally not exceed that which can be done in:

- 15 minutes in Primary 1 and 2
- 20 minutes in Primary 3
- 40 minutes in Primary 4 and 5
- 60 minutes in Primary 6 and 7.

Normally homework will be set each week night, though this may be relaxed for holidays and other special occasions.





#### **ANNUAL ATTENDANCE RATE**

The Annual Attendance Rate for 2019/2020 was 94%.

#### **ASSESSMENT AND REPORTING**

Knowing how your child is performing at school is important. Monitoring progress has always been a key responsibility for teachers. The main purpose of assessment is to:

- 1. Establish through a variety of means the progress that each child is making.
- 2. Assist the teacher in planning appropriate tasks for each child.

Formal assessments are carried out at the end of Key Stage 1 (P4) and Key Stage 2 (P7) and the results of these are included in the child's end of year report. A written record of achievement will be provided for each child transferring from the primary school to a secondary school. Information on the school's end of Key Stage results is available on request. Parents will be informed of their child's general progress at the November Parent – Teacher meetings and through the annual report which is issued in June. The Principal or teacher can arrange a special meeting for an individual parent if there are particular matters of concern. Children on the Special Education Register will have Individual Education Plans or Personal Education Plans, parents will be invited to review their child's progress on these plans with the class teacher or SENCO.

#### COMPLAINTS REGARDING CURRICULUM

In St Francis' PS Aghaderg, we take complaints very seriously. We have the best interests of all our pupils and their families at the centre of all that we do. In this regard, we would encourage anyone with a concern to speak to us as soon as possible. We believe that if concerns are dealt with at an early stage, then they are more likely to be resolved and there is no unnecessary dissatisfaction. Many issues can be dealt with simply by talking to the relevant staff in the school who will be happy to help. Open communication and regular engagement between the school staff, parents/guardians and other school users is vital to the effective management of the school. We welcome open communication with our staff; you can contact our staff by phoning the school or

writing to the teacher to request a meeting. Concerns about matters other than in the classroom should be raised with the Principal. We take all concerns seriously and make every effort to resolve matters as quickly as possible.

Where parents consider that their concern has not been satisfactorily resolved they should follow the Two Stage Complaints Procedure by firstly writing to the Principal; if the parent is unhappy about the investigation, then they should write to the Chairperson of the Board of Governors. Further information is available in the school's Complaints Policy.



#### **CHARGING AND REMISSIONS POLICY**

Education in St Francis' Primary School is provided free of charge for all lessons and activities connected with the child's entitlement under the Education Reform Order. In the event of a school trip or music tuition (not statutory lessons), payment may be required.


The Morning Club, Bus Club and various After School activities are in addition to statutory requirements; these are voluntary activities and payment will be required.

The school may appeal to parents for voluntary contributions but no child will be disadvantaged if parents choose not to make a contribution.
